

**NOTIFICATION**

New Delhi, Date , 2023

G.S.R.\_\_\_\_\_ In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the Ministry of Environment, Forest & Climate Change, Wildlife Crime Control Bureau (Wildlife Inspector) Recruitment Rules, 2000, except as respect thins done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment of the post of Wildlife Inspector in the Wildlife Crime Control Bureau under the Ministry of Environment, Forest & Climate Change, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Ministry of Environment, Forest & Climate Change, Wildlife Crime Control Bureau (Wildlife Inspector) Recruitment Rules, 2023.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. **Number of posts, classification and Level in the Pay Matrix.** - The number of posts, its classification and **Level in the Pay Matrix** attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. **Method of recruitment, age limit and other qualifications, etc.** - Method of recruitment, age - limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the aforesaid Schedule.

4. **Disqualification** - No person,-

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into a contracted a marriage with any person,  
Shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law application to such person and the other party to the marriage and that are there are other grounds for so doing exempt any person from the operation of this rule.

5. **Power to relax.** - Where the Central Government is of the opinion that it is necessary or expedient so to do it may, by order, for reason to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these with respect to any class or category of persons.

6. **Saving.** - Nothing in these rules shall affect reservations, relaxation in age limit and other concessions required to be provided for the Scheduled Casts, the Schedule Tribes, the Other Backward classes, the Ex-servicemen and other special categories of persons in accordance with the order issued by the Central Government from time in this regard.
